## Aug 20, 2020 Sloan Council Meeting

- 1. Mayor Thorpe called the Council Meeting to order at 7:00 PM
  - a. Roll Call: Copple, Bartels, Iverson, Brekke, Stoulil

Also present: Amanda Goodenow, Chris Mitchell, Justin Mitchell, Dan Schoenfeld, Jeff Redmond, Doug Phillips, Diane Peterson, Jim Goodin, Deputy Chris Jansen, Todd Wilson (Maintenance), City Attorney David Briese and City Clerk Dixie Iverson

Mayor Thorpe opened the 1<sup>st</sup> Public Hearing...this was a PUBLIC HEARING on the proposal to sell real estate described as Lot Thirty-Three (33), Walpole Addition, Second Filing to the City of Sloan in the County of Woodbury and State of Iowa. No citizens were present to voice an opinion for or against the proposal. No oral or written comments were ever received after the required notice was published in the Sioux City Journal and posted in five places in Sloan.

Mayor Thorpe opened the 2<sup>nd</sup> Public Hearing...this was a PUBLIC HEARING for the purpose of soliciting written and oral comments on the City's Comprehensive Plan. No citizens were present to voice an opinion for or against the proposal. No oral or written comments were ever received after the required notice was published in the Sioux City Journal and posted in five places in Sloan.

- 3. Doug Phillips with Klass Law Firm introduced himself to the Council. He will be representing the City of Sloan in the Bauer vs. City of Sloan lawsuit. At this time, Mayor Thorpe asked for a motion to go into **CLOSED SESSION** under Iowa Code Section 21.5(1)(c) "To discuss strategy with council in matters that are presently in litigation where its disclosure would be likely to prejudice or disadvantage the position of the governmental body in that litigation." Councilman Iverson said he would look at the area and get back to the Council. Chris Mitchell stated that the alley that runs East/West behind the post office & Sloan Tap has deep ruts. Council instructed the maintenance guys to try and grade the alley to help alleviate the ruts.
