# May 18, 2023 Sloan Council Meeting

- 1. Mayor Copple called the Council Meeting to order at 7:00 PM
  - **a. Roll Call**: Brekke, Burton, Redmond, Larson, Stoulil (Absent)

**Mayor Copple opened the Public Hearing...**this was a **PUBLIC HEARING** on adopting the "proposed" amendment to the City's zoning ordinance pertaining to Lots 1, 2, 3 & 4 of Block 1, Arnold's Addition.
