ORDINANCE NO. 2022-03

**AN ORDINANCE AMENDING THE CODE OF ORDINANCES
OF THE CITY OF SLOAN, IOWA BY AMENDING SECTION
45.02 TO ALLOW FOR ALCOHOL CONSUMPTION IN THE
COMMUNITY HALL**

WHEREAS, Section 45.02 of the City of Sloan, Iowa provides:

PUBLIC CONSUMPTION OR INTOXICATION.

1. As used in this section unless the context otherwise requires:

...

2. A person shall not use or consume alcoholic liquor, wine or beer upon the public streets or highways. A person shall not use or consume alcoholic liquor in any public place, except premises covered by a liquor control license. A person shall not possess or consume alcoholic liquors, wine, or beer on public school property or while attending any public or private school-related function. A person shall not be intoxicated in a public place.

WHEREAS, the City Council of the City of Sloan, Iowa, proposes that section 45.02(2) be **amended** as follows:

2. A person shall not use or consume alcoholic liquor, wine or beer upon the public streets, highways, city park or city ballfields. A person shall not possess or consume alcoholic liquor, wine, or beer on public school property or while attending any public or private school-related function. A person shall not use or consume alcoholic liquor in any public place, except premises covered by a liquor control license, except that a person may be permitted to use or consume alcoholic liquor, wine, or beer in the Community Hall with prior notice of use given to the city. The city shall impose an extra nonrefundable fee of \$50.00 added to the rent amount. A person shall not be intoxicated in a public place.

WHEREAS, the City Council has determined that it is in the best interests of the City of Sloan, Iowa to **amend** Section 45.02(2).

Councilman Burton introduced, cause to be read and moved the adoption of the foregoing ordinance.

Councilman Copple seconded the notion to adopt the ordinance and moved that the Council dispense with the requirement that the ordinance be fully read on three different days.

The Mayor then put the question on the motion to dispense with the three readings, and, upon the roll being called, the vote was:

The foregoing motion having passed by three-fourths votes of the Council, the Mayor then put the question on the adoption and enactment of the foregoing ordinance and upon the roll being called, the vote was:




